## POLICIES AND PROCEDURES

### **POLICIES:**

#### CANCELLATION:

In case of a cancellation of an event, *Tasteful Sensations* must receive a written and duly executed message from the Client. **Events cancelled less than 14 days prior to the date of service are subject to a cancellation fee of 25% of the contract estimate.**

*Tasteful Sensations* guarantees said services agreed upon in the contract. The client has a right to forfeit payment (not including 25% non-refundable deposit) for services if any deviation from the contract occurs (limited to staffing).

### **SERVICE**

#### *Tasteful Sensations*

- has the right to end services immediately based on the actions of excessively rude or unruly guests. The client is responsible for full payment of the contract estimate. The client is also responsible for any additional services provided during the event up until the time of disruption.
- is required by law to serve only persons age 21 and over
- has the right to refuse to serve alcohol to anyone that is visibly intoxicated.

### **INDEMNIFICATION / LIABILITY:**

#### *Tasteful Sensations'*

- total liability for all work performed is limited to the value of the project, as quoted in the Agreement.
- does not have a liquor license to serve guests. Events whereby monetary transactions will be exchanged (e.g. cover charge, cash bar, gambling) on the premises require a liquor license. Be sure the facility you are renting to host your event has a retail liquor license, if applicable.
- is not liable for the consumption of alcohol by a minor received from a legally aged guest of the event.
- is not liable for consequential, incidental, punitive, special, exemplary or indirect damages caused as a result of the actions of any guest that has been served by the former.
- is not liable for any health and/or social hazards of the event due to the consumption of alcohol including, but not limited to, alcohol poisoning, and drunk driving.

### **MISCELLANEOUS:**

*Tasteful Sensations'* suggestions and recommendations are based on expertise and should be regarded as sound professional advice to achieve the best level of service. Consequently, *Tasteful Sensations* is not responsible for any negligence, damages, or other loss of service due to client's failure to adhere to said suggestions and recommendations.

All quoted amounts are based on the assumption that all materials – liquor, glassware, paper goods, ice, garnishes (e.g. limes, lemons, cherries, olives) and miscellaneous items (e.g. umbrellas) will be provided by the Client.

Complimentary consultation for liquor and other supply purchasing is provided at the client's request. Requests for *Tasteful Sensations* to supply any of these items will result in increased charges, variable on requested items. Payment for alcohol and other supplies must be received 30 days prior to the event date.

Receipts and refunds (where applicable) will be given to the client within 30 days after the event date.
